To qualify for associate membership, organizations must submit proof that their operational system meets ISEAL's entry-level criteria, including demonstrating that their standard-setting activities align with ISEAL's Codes of Good Practice.

ISEAL's approval of Equitable Origin's submission recognizes our carefully designed consultation process and governance structure. From the beginning, Equitable Origin's activities have focused on consultation, involving a range of interested parties – from indigenous groups, academics and NGOs to government agencies, international organizations and financial institutions – to ensure that their views are taken into account. "We used the ISEAL criteria as a roadmap for what our consultation process should look like, as they are the leaders in good practices for standards development," said Poritz. "Our approval as an ISEAL associate member is welcome recognition of our commitment to participation and inclusiveness."

Equitable Origin's role as the first initiative from the oil and gas sector to achieve ISEAL membership marks an important achievement in what is often considered a controversial sector. Speaking about the announcement, ISEAL's Executive Director Karin Kreider noted, "Credible, market-based standards have a strong role to play in driving improved practices in the most challenging of industries. In sectors where the potential for negative impacts is large, we should be supporting those systems working to address key social and environmental issues."

Associate membership is the first step along the path to full membership, which requires compliance with ISEAL's Codes of Good Practice, including the Standard-Setting Code and the Impacts Code. ISEAL provides its members with a valuable forum where standard-setting organizations can come together to demonstrate the credibility of their systems and share lessons and experiences to help promote good practices.

"ISEAL provides an important set of 'touchstones' for transparency and credibility," noted Michael E. Conroy, member of the Equitable Origin Board of Directors (and an ISEAL subscriber). "We are delighted that our initial efforts to build the Equitable Origin system have met the requirements for becoming an ISEAL associate member and we look forward to working with ISEAL's codes, experience and technical support to complete the development of the system and become full members as quickly as possible."
