

EO100™ Standard Review – 2014-2016

Phase I Summary Report

January – December, 2014

Background:

In 2013, the Equitable Origin Standards Board approved a comprehensive review of the EO100 Standard to start in 2014 based on lessons learned since the initial publication of the EO100™ Standard¹ in February, 2012. These learnings have come through our work with oil and gas operators to implement the EO100 Standard, through our efforts to develop policies, procedures and training for third party auditors to conduct certification audits to the Standard, and through feedback we have received from users of the Standard (companies, auditors and consultants) and other interested and affected stakeholders.²

Review Timeline:

The review process involves three phases, including two public comment periods and multiple workshops:

Phase I: January – December 2014

- Review of stakeholder comments received since 2012 and revision of the EO100 Standard (Principles, Provisions³ and Performance Target (PT) 1s) by the [EO Standards Technical Committee](#)⁴
- Development of stakeholder consultation methodologies and stakeholder mapping
- Consultation events and workshops
- 60-day public comment period on the EO100 Standard (Principles, Objectives and PT1s): October-December, 2014⁵

Phase II: January – December 2015

- Review of stakeholder comments received in Phase I and revision of the EO100 Standard (Principles, Objectives and Performance Targets) by the EO Standards Technical Committee
- Expansion of scope of the EO100™ Standard to incorporate other types of energy development projects (approved by the EO Board)

- Review of stakeholder comments and revision of the EO100 Standard (Principles and Objectives) by the EO Standards Technical Committee
- Final approval of revisions by the EO Board.
