- Develop and track key outcome and impact indicators in alignment with program goals and EO's overall Theory of Change
- Manage program implementation and ensure consistent, high-quality program delivery
- Identify and recruit local implementation resources and partners
- Document and report on all program activities and outcomes
- Collaborate with senior management team on program activities and alignment with EO's short- mid- and long-term goals

- Build and expand stakeholder relationships among various constituencies
- Establish local academic partnerships for the purpose of convening stakeholders for program activities
- Represent EO at industry and stakeholder events and in relevant state and regional organizations
- Business development related to the EO Platform

- Knowledge of the market, regulatory, technical, environmental, and social context of energy development in Texas
- Facility communicating effectively with a diverse cohort of stakeholders, including individual landowners, grassroots community groups, local government officials, investor organizations, industry groups, and business leaders
- Demonstrably excellent organizational skills
- Tech-savvy and experience working with IT and creative staff on IT troubleshooting and project execution
- Experience supporting a high-performance, collaborative, constructive team
- Excellent verbal and written communication skills with exceptional attention to details
- Strong analytical skills; basic business intuition, and common sense
- Ability and willingness to effectively utilize CRM tools, particularly Work [etc.] and Salesforce
