Total School Fee - \$9,330

Comprising:	Tuition Fee: Year 7 – 12	\$6,990
	Annual Levy: Year 7 – 12	\$1,990
	Capital Levy: Family	\$350

The Annual Levy covers curriculum resource costs including year level camps, excursions, incursions, magazine & school photos, and includes iPad/MacBook lease, warranty, insurance, software licensing and network services, and ownership at end of Year 8 and Year 12. The Capital Levy is to assist with minor building program projects and improvements.

Enrolment Administration Fee

To confirm enrolment, a non-refundable Enrolment Administration Fee of **\$400** is payable.

- eLearning (online textbook platform) subscription: **Years 7-10 \$200**
- Optional programs, camps, e.g. Central Australia, LOTE overseas trips, etc.
- VCE Outdoor & Environmental Studies Subject Levy **\$250**

Charter Bus

Sibling Discount

The College discounts the annual tuition fees for siblings attending Mater Christi based on family position, as follows:

- 2nd Child = 10% (\$699)
- 3rd Child = 50% (\$3,495)
- 4th plus child = 100% (\$6,990)

Catholic Family Discount

The College's Catholic family discount of **\$500** is available as a reduction against Mater Christi fees, for families who have one or more sons attending any Catholic secondary school.

Early Payment Discount

A discount of **\$260** is applicable when the Total School Fee is paid in full by 20 November 2020.

Payment Options

Payment required by Direct Debit (via bank account or Credit Card) can be per Term, Monthly, Fortnightly, or Weekly.

First instalment is due by 20 November 2020, with final payment of the year's fees due by 20 October 2021.

Early Withdrawal

A full term's notice (10 weeks) in writing to the Principal is required, in accordance with the Conditions of Enrolment, when withdrawing a student from the College, or 25% of the Total School Fee is payable in lieu of this notice.

Late Payments

Students may be ineligible for optional / extra-curricular programs (e.g. instrumental music lessons, music camp, Central Australia trip and overseas trips) when payment arrangements are not honoured, and communication is not maintained. We encourage any parent experiencing fee difficulties to contact the Finance Team.
