ACTUAL EXAMPLE (Q1 2017) of documents required and process for a long-term Thailand-based senior business executive to renew visa and work permit for self and wife. In this case a professional firm has been engaged to assist. The professional firm has prepared the time table and documents required. Their fees are noted.

Total documentation submitted for this purpose in 2016 was advised to be 233 A4 pages.

For the period of 20 years in Thailand there have been over 20 copies certified by the foreign Embassy of his and his wife's marriage certificate.

The person concerned notes that he first arrived in Thailand 35 years ago to work and in his various official positions he has had a number of meetings with Thai officials to discuss "ease of doing business". He notes that even with OSOS and a very limited number of ad hoc online processes (which in this case have no material impact), as far as visa and work permit there have been no material progress in these 35 years.

Whilst OSOS for some has been an improvement new requirements have had the effect that the inefficiency, waste of time and money and unnecessary documentation have expanded.

He believes this is not only costly and inconvenient for all but continues to harm Thailand's reputation as a place to do business.

The work permit and visa area does not seem to be addressed and continues to impact Thailand 'ease of doing business'
