Experience with Renewal of Business Visa and Work Permit

I am writing to bring awareness about the difficulties faced by foreigners required to renew Non-Immigrant Business Visas to legally reside in Thailand. I have been living in the Kingdom of Thailand for five years and remain wishful that the renewal of visas and work permits could be more efficient and effective. I hope this letter brings some clarity to my current situation and the potential to improve the visa and work permit process to legally reside and pay taxes in Thailand.

In the past 4 months, I have interacted with the staff of the Pathumthani Immigration Office to renew my business visa. During this time there have been multiple requests for additional documentation such that numerous visits to this office were required. This may be due to my lack of understanding of the renewal process and/or that the government office staff is quite busy such that I experienced a slow turnaround and non-responsiveness. For this, I would like to understand any underlying concerns and reasons as to why this occurred. In all honesty and transparency, with the recent treatment experienced in this business visa renewal process I do question my future to reside in the Kingdom of Thailand under such circumstances. Also, as part of my inquiry, I would seek to obtain clarity about the future ability (August 2018) to hold a Spousal Visa and the possible allowance of my employer to provide myself a work permit. If this is not possible, and the issues in renewing my business visa and work permit continue, I would need to consider to exit the country and move to a more business friendly environment in SE Asia.

In terms of background, I am a Masters educated individual working in the Asian agriculture sector. In the past years, I have executed the visa renewal process through the use of a lawyer/agent and the process was quite smooth and efficient but was still lengthy and did incur considerable fees. At the end of June this year I changed employers and was required to cancel my visa and work permit. In this process, my new employer execute the work permit/visa process. This should have been no more troublesome and I would have hoped that the Bureau of Immigration staff at the Pathumthani Immigration office had been more transparent in how to navigate the process by being more clear and upfront as to the documentation required. In the current situation up to 7 visits to the Pathumthani Immigration office were required plus multiple other trips to government offices to complete this process. After every subsequent visit more and more forms, documents, and meetings were being requested such that over 80 hours were needed to gain approval. As this process was quite lengthy and difficult to explain I have thus summarized and provided the timeline of events in Appendix 1 below and attached spreadsheet. Also, as point of reference and example of other countries visa applications, in past two weeks I recently obtained a 1 year multiple entry business visa with the Indian Embassy in Bangkok and completed this process in under 10 days. I may wish that the Thailand business visa application and renewal would be as timely and efficient.

Overall, I do understand that there are requirements that need to be upheld and a level of security maintained as to those residing in the country. I have made a commitment to the Kingdom of Thailand over the past years and wish to support Thailand as an attractive place

to conduct business. Unfortunately recent events reveal the opposite and something that inevitably needs to be questioned in deciding my future residency and career options. I have been a tax paying net contributor to the Thailand economy for the past 5 years along with a Thai wife and daughter whom we wish to raise in this country. However, after the troubles to do a simple Business Visa renewal, I have to take this experience into consideration when deciding my future employment opportunities and unfortunately have to consider the option of moving my tax dollars and funds elsewhere.

I hope the process can be further improved or refined and I see the following as shortcomings which should be corrected:

- 1) Clearly and transparently identify the requirements about documents up-front (not drip-fed).
- 2) Streamline the process and reduce paperwork and evidentiary requirements; revised the standard of proof
- 3) Align or have similar durations for renewal of work permit and visa process.
- Confirm the circumstances in which a Spousal Visa through Chaeng Wattana Immigration office is available <u>and</u> combined with a work permit in Phatumthani district – looking ahead to August 2018.
- 5) Move to web based or online applications for all companies not just those supported by the Board of Investment (BOI)? Thailand has spent a lot promoting the digital and 4.0 economy. What are the efforts to bring this process on-line and what is the time frame in achieving?

In closing, I hope an understanding of this situation it can provide the necessary tools and steps to streamline and improve the overall process and make more efficient use of applicant and government officials' time in conducting visa and work permit renewals.
