#### 3 main objectives

- 1. Collective action peer pressure
- 2. Education; Business has to understand the value of reducing corruption and economic destructive value
- 3. Rule of Law understanding
- 4. Remove criminal defamation except for extreme cases, most are civil
- 5. Better understanding of international / extra territorial norms
- 6. State action must be seen to be effective
- 7. Symbolic and standard-setting government action
- 8. Powers in anti-corruption bodies effective and fair whistleblower protection; witness protection
