The Asian Institute of Technology (AIT, <u>http://www.ait.asia</u>) has been implementing an EU-financed project entitled: *"Sustaining and Enhancing the Momentum for Innovation and Learning around the System of Rice Intensification (SRI) in the Lower Mekong River Basin"*. The main objective of the project is to contribute to enhance resilience of rainfed small-scale farmers of Lower Mekong region confronting climate change. The **purpose** of the evaluation is to assess the progress made by SRI-LMB project towards achieving expected results, purpose and overall objective, document lessons learned and make recommendations for possibilities of continued long-term benefits from project achievements. The evaluation will cover the whole project period since its implementation began in 2013. In terms of geography, it will focus on all the four project countries of Cambodia, Laos, Thailand and Vietnam.
