



PLVU is only 1/8" thick, provide maximum footstep noise reductions and will provide a much quieter spave below.

Privacy Luxury Vinyl Underlay ™ is a locally reactive floor soundproofing product; it absorbs the vibration caused when footsteps occur, at the source. Footstep vibration is significantly reduced before it travels into the structure. Utilizing a soundproofing underlay when installing your floor, will create far quieter rooms below in your home or office.

PLVU ™ is installed with the fabric side up, wall to wall with no gaps. Adhesive is only required if the finished floor is to be glued as well. Simply cut sections off the roll to fit your room dimensions.

For real soundproofing results a one-size-fits-all products will not work. We have specific products for each floor type, in different thickness to help with smooth transitions from room to room. Start your soundproofing project with the right company, to be sure your project will be successful!





### PRIVACY ULTIMATE UNDERLAY™ INSTALLATION GUIDE FOR LVP

Do not deviate from instructions below. Installation of PUU with Luxury Vinyl requires specific adhesives and steps.

- Unroll product and allow to acclimate for 24 hours. Clean floor and remove debris; if required use patch to level floor.
- Install perimeter isolation strip around room and any exposed pipes, columns or other penetrations. Verify direction of finished floor, cut rolls to size and install perpendicular to finished floor. Begin installation in center of floor, all butted edges should be factory cut if possible. Trimming should be done at perimeter. Use acoustical sealant and foil seam tape all interior seams- no sections less and 12" x 12" are to be used.
- Luxury Vinyl Planks only; sheet vinyl, VCT or Luxury Vinyl Tiles are not acceptable. For glued plank installation Privacy Eco-Urethane adhesive is required to install PUU to subfloor. Use full spread method and appropriate trowel size as shown on adhesive label for underlay thickness. After installation, roll entire area with 150 lb roller.



Apply a 100% skim coat using flat edge of trowel to fill granular surface and insure that entire surface of PUU has been covered. **Allow to dry completely** before installation of planks.\*\* In humid climates a 24 hour drying period is recommended. Follow manufacturers instructions for trowel size when installing planks.

When installation has been completed, cut away any excess perimeter strip, caulk perimeter and install trim or baseboard.





# PRIVACY ULTIMATE UNDERLAY™ LIMITED LIFETIME WARRANTY

- 1. Privacy Ultimate Underlay™ is guaranteed and warranted to be free of manufacturing defects in material and workmanship for 20 years from the original date of purchase, by the original purchaser (Warranty Period). If defects in material and/or workmanship are reported and determined to be present by the good-faith determination of Sound Isolation Company, during the warranty period, Sound Isolation Company's liability will be limited to actions listed in Part 6 below.
- 2. Sound Isolation Company shall not be responsible for any damage, loss, or claim whatsoever unless the material is installed according to the written instructions provided by Sound Isolation Company and used only as intended by Sound Isolation Company, including the use of Privacy Floor Adhesives for installation.
- 3. Privacy Ultimate Underlay can be installed under most types of flooring installation products including ceramic tiles and many stone tiles, carpet, carpet tiles, hardwood, parquet laminate, LVP and engineered wood for floors used under "light" performance levels under ASTM C627 for commercial use in office space, reception areas, kitchens, and bathrooms; Wood subfloors must be a minimum of 1" thick double construction and qualify as to deflection under ANSI deflection standards (L/360 for tile and L/720 for stone minimums): For installing ceramic tile over Privacy Ultimate Underlay, a high quality latex modified thinset mortar is required. These may be labeled as Full Flex, Super Flex, or Multi Flex thinset mortars. Flexible grout is also suggested.
- 4. Moisture problems with concrete subfloors are specifically excluded and slabs must be wet-cured for a minimum of 25 days before installing Privacy Ultimate Underlay™ and any claim made herein must include a certifiable concrete subfloor moisture testing result at the time of installation. Additionally, subfloors including concrete, must be clean, dry, smooth, and structurally sound and if leveling problems are encountered they must be addressed by the Contractor before installation of Privacy Ultimate Underlay ™ by proper fill, patching, and/or self leveling compounds.
- 5. Recycled rubber products may present an odor when unpackaged. All products should be unpackaged and unrolled 72 hours prior to installation. Our experience has shown that any odor, if caused by the product, will dissipate quickly over time. There is no warranty provided for the presence of any odor when Privacy Ultimate Underlay™ is purchased or installed.
- 6. Our liability is limited to the repair or replacement of products, which are shown to be defective during the Warranty Period, except, at Sound Isolation Company's sole discretion a credit may be issued not exceeding the original purchase price of the product. The owner/purchaser agrees not to advance any claim for any other measure of damage or loss. Sound Isolation Company shall not be liable for installation, disassembly, removal, disposal, return shipping, or other similar or related costs, including consequential and incidental damages.
