## 1) Principal's Update

- a) Ms. Barash and Principal Paniagua went to Washington D.C. for the National Blue Ribbon ceremony.
- b) Quality Review.
  - i) The school received "Well Developed" in all categories.
  - ii) Same result as in 2015.
  - iii) Only 1% of schools in NYC achieve this.
- c) Parent-teacher conferences went very well.
- d) Media center computers and furniture coming by the end of the month.
- e) Reso A budget item granted last year for two new bathrooms, boys and girls, on 1st floor.
  - i) Handicap accessible.
  - ii) Renovations over the summer for approximately 6-week project.
- f) Academic progress:
  - i) Math:
    - (1) In June, 81% were proficient (3s and 4s).
    - (2) In Envision program, in first cycle of school year, still 81% proficient.
    - (3) That is a very good result, because when Go Math was first implemented, there was a dip.
  - ii) Reading:
    - (1) Using Teachers College benchmarks, 69% are on or above grade level; the CEP goal is 81%.
  - iii) Writing:
    - (1) 87% are on or above grade level.
    - (2) There is usually a dip in the first cycle compared to the end of the previous year, so this is a very good result and better than the previous year.
  - iv) AIS (Academic Intervention Services) Data:
    - (1) School is targeting 2s to get them to 3s.
    - (2) 92% went up in levels but not in Teacher College Reading and Writing benchmarks; elevating benchmarks is goal for second cycle.
    - (3) In second cycle, school will assist not just AIS children but also non-AIS kids to meet the goal.
- 2) Parents Association Update.
  - a) Tomorrow is the school celebration of the National Blue Ribbon award.
    - i) Speakers will include New York City Council Member Karen Koslowitz and New York State Senator Joseph Addabbo.
    - ii) Teachers and students will also receive awards.
  - b) The next PA event is the Scholastic Book Fair.
    - i) Books will be pre-screened.
    - ii) There will be a reading competition.
    - iii) There was a PA meeting this morning.
    - iv) Ms. Kaminsky presented on Envision Math

- v) Mr. Puma presented on Elevate Science.
- vi) A vote will be held on iPads at the January meeting.
- c) The Holiday Giving campaign kicked off.
  - i) The goal is \$50,000.00.
  - ii) Companies can match.
- d) Community service projects ongoing.
- e) Residency open houses will take place over two days.
- f) District diversity plan development soon underway.
  - i) WXY will present to the public, and may come to the school as well.
  - ii) The President's Council has asked the PA to convey information to the school.

## 3) CEP

- a) One of the goals was to enhance social-emotional maturity and control, and this is a success so far, as seen in a significant drop in recess incidents between this October and last October.
- b) The Math goal was 85% proficiency, and the school is at 81%.
- c) Reading is at 69% and Writing is at 87%.
  - i) That averages out to 78%, and the overall ELA goal was 81%, so this is not very far off.

    - i) Enrichment:
      - (1) Self-directed projects with different themes on the "Mastery Model."
    - ii) Social-emotional:
      - (1) Mood meters outside of class, even for parents; welcome packets for new students; more RULER workshops for parents.

      - (1) In higher grades, more task-oriented work.
      - (2) Can also be collaborative or "jigsaw" homework in which kids work on different aspects of joint project.
