This model focuses almost entirely on long-term growth through the capital appreciation of a broadly diversifed pool of global equities. The holdings consist of mutual funds and exchange traded funds invested primarily in the following asset classes:

- U.S. Large Cap Equities
- U.S. Mid & Small Cap Equities
- International Equities
- Emerging Markets
- U.S. Government & Corporate Bonds

The portfolio is more heavily weighted in equities than in fixed income, and relies mainly on capital appreciation for portfolio growth.
