- U.S. Government Bonds / TIPS

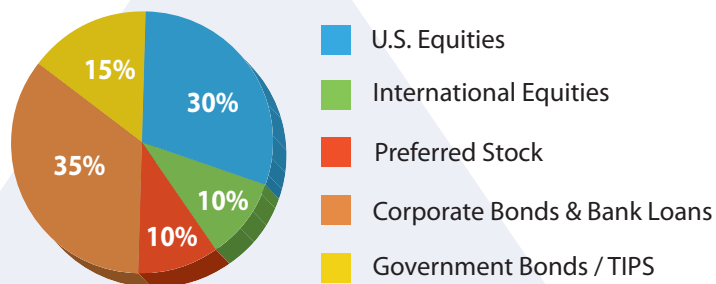
