Neighborhood Project Update

As we welcome Fall, various elements of Chesterfield Heights and Grandy Village are changing to reflect forward progress in the Ohio Creek Watershed Project. The project continues to move forward with berm, road, park, and improved infrastructure construction to enhance the area and mitigate flooding impacts.

Current highlights of the project include progress on Kimball Terrace West and the road improvements to access Campostella Road. Utility work on Marlboro Avenue continues in earnest as well. Over the last 8 months, the City of Norfolk and MEB General Contractors Inc., have made noticeable progress in advancing this element of the project.

We sincerely appreciate your patience as we make great strides building Norfolk's coastal community of the future.



Road construction progress will continue over the next few months. Once complete, residents and visitors will have unparalleled transit access with reduced effects of flooding impacts.

Anticipated road completion is scheduled for 2022.
