Points of Clarification:

Improvement Plans:

Replace Log Vein Detail shown on Sheet C11 with attached. The detail included in the improvement plans issued for bidding did not include following construction note.

"SECURE LOG WITH DUCKBILL ANCHORS OR APPROVED EQUAL DRIVEN ANCHOR MECHANISM TO PREVENT LOG DISPLACEMNET DURING HIGH VELOCITY FLOWS IN THE RIVER. REFER TO NRCS TECHNICAL SUPPLEMENT 14E, USE AND DESIGN OF SOIL ANCHORS AND FOLLOW THE MANUFACTURE RECOMMENDATIONS."

Except for above-mentioned note, no other changes were made to this detail.

Project Manual:

- Previously issued Addendum Number 1 containing replacement sheet Division 2 –
 Instructions to Bidders Page 9 of 11 was accidentally included a repetition of Division
 2 Instructions to Bidders Page 5 of 11. Please replace Page 9 of 11 with the
 attached revised sheet in the Project Manual.
- Division 3, Bid Form: There were typos in the estimated quantities for Project Three Charney Ranch, Location 2, Area 2 and Project Four Charney Ranch, Location 2, Area 1. No log veins are proposed in Project Three Charney Ranch, Location 2, Area 2 and these three log veins should have been included in Project Four Charney Ranch, Location 2, Area 1. Please either correct the typo manually in the Bid Schedule or replace Page 6 of Bid Schedule issued through Addendum No.1 with the attached with your bid submittals.

- The log veins will be provided by the Owner and the Contractor shall pick up the log veins from Holbrook Ranch and transport to the project sites where the log veins are used.
- The riprap required for toe and slope stabilization, rock refusal trenches and around log veins maybe obtained from Brunswick Canyon pit in Carson City at the estimated costs below or the contractors may source these construction materials elsewhere as long as they meet the specifications shown on the bid documents:

Class 300 riprap: \$13/tonClass 700 riprap: \$15/tonClass 900 riprap: \$24/ton


General:

Water Master would allow diversion of river flows upstream of Flying J Ranch, Location 2, which would help with dewatering and diversion of river flows near work areas at all project locations.

As part of the diversion and dewatering effort, minor modifications to existing irrigation control structures maybe permitted as long as these irrigation structures are restored to original conditions.

ARTICLE 19 – EVALUATION OF BIDS AND AWARD OF CONTRACT

- 19.01 Owner reserves the right to reject any or all Bids, including without limitation, nonconforming, nonresponsive, unbalanced, or conditional Bids. Owner further reserves the right to reject the Bid of any Bidder whom it finds, after reasonable inquiry and evaluation, to not be responsible. Owner may also reject the Bid of any Bidder if Owner believes that it would not be in the best interest of the Project to make an award to that Bidder. Owner also reserves the right to waive all informalities not involving price, time, or changes in the Work and to negotiate contract terms with the Successful Bidder.
- 19.02 More than one Bid for the same Work from an individual or entity under the same or different names will not be considered. Reasonable grounds for believing that any Bidder has an interest in more than one Bid for the Work may be cause for disqualification of that Bidder and the rejection of all Bids in which that Bidder has an interest.
- 19.03 In evaluating Bids, Owner will consider whether or not the Bids comply with the prescribed requirements, and such alternates, unit prices and other data, as may be requested in the Bid Form or prior to the Notice of Award.
- In the comparison of Bids, alternates will be applied in the same order of priority as listed in the Bid Form. To determine the Bid prices for purposes of comparison, Owner shall announce to all bidders a "Base Bid plus alternates" budget after receiving all Bids, but prior to opening them. For comparison purposes alternates will be accepted, following the order of priority established in the Bid Form, until doing so would cause the budget to be exceeded. After determination of the Successful Bidder based on this comparative process and on the responsiveness, responsibility, and other factors set forth in these Instructions, the award may be made to said Successful Bidder on its base Bid and any combination of its additive alternate Bids for which Owner determines funds will be available at the time of award.
- 19.05 In evaluating Bidders, Owner will consider the qualifications of Bidders and may consider the qualifications and experience of Subcontractors, Suppliers, and other individuals or entities proposed for those portions of the Work for which the identity of Subcontractors, Suppliers, and other individuals or entities must be submitted as provided in the Supplementary Conditions.
- 19.06 Owner may conduct such investigations as Owner deems necessary to establish the responsibility, qualifications, and financial ability of Bidders, proposed Subcontractors, Suppliers, individuals, or entities proposed for those portions of the Work in accordance with the Contract Documents.
- 19.07 If the Contract is to be awarded, Owner will award the Contract to the Bidder whose Bid is in the best interests of the Project.
