



Tennis Court Usage Policy

Background and Guiding Principles

ASRC is a member owned club. Accordingly, collective interests of all the members are the determining factor in allocating tennis court time. ASRC recognizes the need for non-member participation in junior tennis programs, adult group lessons and USTA adult leagues. However, such non-member participation is intended to be limited and, in part, to enable members to receive high quality junior tennis programs, adult group lessons and USTA league experience. In case of conflict of interests between members and non-members, the member's interests shall prevail. At least annually, or more frequently, if needed, this tennis court usage policy shall be reviewed, and amended as needed. Policy regarding participation of non-members in USTA leagues is described in a separate document. This document describes the policy regarding court usage for junior tennis program, lessons for members, adult individual lessons and adult group lessons.

The following rules apply during 8:00 am to 3:00 pm on Weekdays

1) Court 1 shall be reserved for possible lessons for either members or non-members that may or may not occur. The Club is extending lessons to non-members during this time with a view to serve the community around the Club and attract new members to the Club.

The following rules apply during 3 pm to 6:30 pm on Weekdays

- 1) Courts 4, 5, 6 and mini court shall be reserved for junior tennis programs;
- 2) Court 1 shall be made available for lessons by a tennis professional to adults or members of the Club. In the event no such lessons are being conducted, court one is reserved for junior tennis program; and
- 3) Courts 2 and 3 shall **not** be reserved for lessons or junior program. These courts are available for reservation by only members. Members may reserve the courts in advance or walk in when there is no such reservation. **In the event these courts are not being used by members, they may be utilized by coaches leading junior programs.** It is incumbent on the tennis coaching professional using courts two and/or three to monitor members coming into the tennis area and must offer use of those courts to members when observed. Failure to offer could result in member complaint, which could result in restrictions on use.

The following rules apply during 6:30 pm to 8:00 pm on Weekdays



1) Court 1 (or Court 6 in event USTA match is scheduled on Court 1) may be reserved for previously scheduled lessons by a tennis coach to individual **members of the Club** or a group comprised of at least **two members of the Club**. Tennis coach shall not reserve the court for possible lessons that may or may not occur. Tennis coach shall cancel unneeded reservations promptly (at least 8 hours prior to the reservation start time). Members are expected to schedule a lesson with the tennis coach at least a day in advance. Coaches are expected to avoid scheduling lessons when all other courts are booked for drop in and USTA matches. Members may personally reserve any available courts for the purposes of recreational or instructional tennis play from a Tennis coach.

The following rules apply during Saturday

1) Court 1 shall be reserved from 10 am to 3 pm for possible lessons for either members or non-members that may or may not occur. The Club is extending lessons to non-members during this time with a view to serve the community around the Club and attract new members to the Club. Before 10 am Court 1 shall be reserved only for Adult drop-in.

2) Court 6 shall be reserved for 11 am to 3 pm for possible lessons for either members or non-members that may or may not occur. The Club is extending lessons to non-members during this time with a view to serve the community around the Club and attract new members to the Club. Before 11 am Court 6 shall be reserved only for Adult drop-in.

3) After 3 pm Court 1 may be reserved for previously scheduled lessons by a tennis professional to either members or non-members. Tennis coach shall not reserve the court for possible lessons that may or may not occur. Tennis coach shall cancel unneeded reservations promptly (at least 8 hours prior to the reservation start time). The Club is extending lessons to non-members during this time with a view to serve the community around the Club and attract new members to the Club.

The following rules apply during Sunday

1) After 11 am Court 1 may be reserved for previously scheduled lessons by a tennis professional to either members or non-members. Tennis coach shall not reserve the court for possible lessons that may or may not occur. Tennis coach shall cancel unneeded reservations promptly (at least 8 hours prior to the reservation start time). The Club is extending lessons to non-members during this time with a view to serve the community around the Club and attract new members to the Club.
