Enter **your USDOT#** in the box marked **FID, SSN, TID, or USDOT#**. *Because the majority of our customers claim exemption as a provider of public transportation and provide us with their USDOT# as part of that claim, we have made the decision to use the USDOT# as our pump prompt to tie the exempt diesel purchase to the exemption certificate that supports that exemption.*

If you do not have your own USDOT#, enter **your FID (FEIN) or SSN** in the box marked **FID, SSN, TID, or USDOT#**.

Enter **your MC# / ICC #** in the box marked **FHWA# (formerly ICC#)**.
